All Food Booths must have a current <u>Shasta County Health Permit</u> 30 days in advance of event. **This is your responsibility.** There will be a County Inspector on the grounds Saturday morning to check on compliance. If you are shut down by the County, you will not get a refund. It is also the Vendor's responsibility to obtain a **Resale Permit from the California State Board of Equalization**, <u>if required</u>.

Receptacles will be provided at several locations for exhibitor trash. There will be receptacles placed throughout the Festival area for public use. Each Vendor is responsible to maintain cleanliness of their booth and the surrounding area.

NO outside alcohol, pets, or smoking shall be allowed on the Honey Bee Festival premises.

I/We understand that the Palo Cedro Honey Bee Festival Committee/Palo Cedro Community Park Committee reserves the right to ask me to leave the Festival without a refund if my exhibit does not conform to the booth application form or rules and regulations governing all Exhibitors. The Palo Cedro Honey Bee Festival will be held regardless of weather conditions.
